Sale Entry Forms: selling 'Performance' Mules? Please note

Members who are selling both 'Performance' Welsh Mules and the regular Welsh Mules need to remember to complete the reverse of the relevant sale entry form to choose the order that wish to sell their sheep. The following shows an example from the sale entry form of a member selling nine lots of sheep, three of them being 'Performance' Welsh Mules and he wants to sell them last. He should do that by indicating that by placing the letters **PM** against the relevant lot numbers.

Sale Inspections & Yearling Ewes: a gentle reminder!

All members who enter sheep for sale at the association's sales, sign the sale entry form to say that they accept the Conditions of Sale Entry.

Those conditions stipulate that all sheep entered for sale can be inspected by an inspector appointed by the association to ensure that standards are maintained. By signing, the vendor is accepting that the decision of such inspectors is final and while vendors and inspectors can ask for guidance from an association referee, the last word rests with the inspectors. While that may appear unduly harsh to many, that is a condition of sale entry that has been insisted upon since the association's first sales.

As was pointed out to members last year, one of the issues that causes most problems is when yearlings bought as ewe lambs at an association sale are subsequently rejected by inspectors the following year because they are not considered to be true to breed type when entered for sale as yearlings. It has happened on a number of occasions and happened last year again. Vendors naturally get a bit annoyed with association inspectors but unfortunately, some yearlings will develop later that others and characteristics do come to light that would have been difficult to spot when those yearlings were ewe lambs.

We therefore re-iterate that the association's policy is (regrettable as it may seem) that yearlings may very well have to be rejected by inspectors as not true to type if they later develop characteristics that are not those of the Welsh Mule.

EIDCymru update from HCC

EIDCymru, the new livestock traceability database for Wales, is reaching the final stages of preparation.

EIDCymru has been developed from the successful ScotEID system to deliver for the Welsh industry.

The electronic reporting of sheep movements by livestock markets as well as by abattoirs, collection centres and gatherings will be compulsory from January 2016.

To assist these businesses in meeting this legislative requirement, EIDCymru has appointed a technical team to support businesses in meeting this new requirement.

The EIDCymru technical team is led by John Richards (who has been seconded to this role from Hybu Cig Cymru) and John will be working alongside Jonathan Pryce who has substantial experience in supporting users of farm software systems.

Their aim is to help businesses to meet the requirements for reporting movements electronically as easily as possible and with the minimum disruption to their business.

The team have already begun liaising with the businesses, organisations and individuals for whom electronic report-

ing will be compulsory in Wales to help them set up the systems needed to report sheep movements electronically.

They have had an extremely positive response to their offers of help and several markets have already offered to be involved in the pilot phase prior to launch.

Sheep keepers will be encouraged to report moves electronically after January but paper-based movements will still be facilitated via the EIDCymru office.

A dedicated helpdesk service is currently being established in Aberystwyth and this will be operational from the autumn to provide support to all EIDCymru users.

Industry stakeholders on the Livestock Identification Advisory Group (LIDAG) and individual farmers on the EIDCymru focus group will continue to be involved in the final stages of development so that the system is user friendly and the maximum benefit is gained from these positive changes.

A series of farmer meetings and information events is planned for the late autumn and throughout 2016.

Other News:

Mr Ceiriog Jones, Cilgoed, Derwen, Corwen was appointed the new Association President at the AGM of members, succeeding Welshpool auctioneer, John Jones. Mr Gwyn Davies, Llanfechan, Garth, Builth Wells was elected Vice-President. Ceiriog's appointment is quite unique as Ceiriog's father, Emyr also served as President, the first time that a father and son have held the post.

Important: Changes to tagging options from 1st January 2016

Don't be caught with too many of the wrong kind of tags on your hands!

Members are reminded that from 1 Jan 2016, **non electronic** slaughter tag will not be permitted as the single tagging

option to identify lambs intended for slaughter.

Keepers should carefully consider the quantities of non electronic slaughter tags ordered in 2015 as any surplus tags can-

not be used to identify lambs from 1 Jan 2016.

The table below illustrates the sheep tagging options available to you from 1 Jan 2016

Full EID	Lambs kept beyond 12 months of age for breeding purposes
	Store/finished hoggets intended for slaughter but kept beyond 12 months of age
	Lambs intended for live export.
Electronic slaughter tag or Full EID	Lambs intended to be slaughtered in an UK abattoir prior to reaching 12 months of age

REMINDER:

We would be grateful if members could ensure that they choose the correct sale entry form to complete when entering sheep for sale.

Yearlings and older ewes, please use the **WHITE** forms;

Ewe Lambs, you need to use the **BLUE** forms and

Performance Mule Ewe Lambs, please use the **YELLOW** form.
